- **Furnish** - we collect unwanted furniture and redistribute it to vulnerable and homeless people.
- **Home Improvement Agency** - we improve vulnerable people's homes through repairs and adaptations, leading to a better quality of life.
- **Housing Advice Service** - we provide housing, debt and welfare benefit advice to clients in housing need.
- **Small Repairs** - we carry out more than 1,000 small repairs each year for people over 60.
